1.	<p>INTRODUCTION</p> <p>This Privacy Policy (hereinafter referred to as the “Policy”) sets forth the general rules of collection, processing, distribution, use and storage of Website user’s Personal data including any dispute concerning privacy under current General Data Protection Regulation (GDPR), and in accordance with the data protection regulations applicable to the Connectico (hereinafter the “Connectico”, “Company”, “Us”, “We”).</p> <p>It is understood and presumed that by the fact of use of the Website and its services or by clicking “REGISTER” button the User gives Consent, that he/she/it has fully read, understood and accepted this Policy. 2.	<p>DEFINITIONS - the following definitions and rules of interpretation apply in this Privacy policy:</p> <p>a. Personal data Personal data means any information relating to an identified or identifiable natural person (“data subject”). An identifiable natural person is an individual that can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, address or other identification data.</p> <p>b. Data subject Data subject is any identified or identifiable natural person, whose personal data is processed by the controller responsible for the processing.</p> <p>c. Processing Processing is any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction.</p>

5.	<p>LEGAL BASIS FOR THE PROCESSING OF PERSONAL DATA</p> <p>All personal data of data subject is processed with aim of compliance with a legal obligation under Art. 6(1) lit. of GDPR under which data controller is obliged to receive consent of data subject for specific processing operations with personal data.</p>
6.	<p>COLLECTION OF PERSONAL DATA AND INFORMATION</p> <p>The Website of the Connectico collects a series of general data and information when a data subject or automated system calls up the website. This general data and information are stored in the server log files.</p> <p>The following information may be collected for general purposes:</p> <ul style="list-style-type: none">a. the browser type and its version;

Rather, this information is needed to 1) deliver the content of our website correctly; 2) optimize the content of our website as well as its advertisement; 3) ensure the long-term viability of our information technology systems and website technology; 4) provide law enforcement authorities with the information necessary for criminal prosecution in case of a cyber-attack. Therefore, the Connectico analyzes anonymously collected data and information statistically, with the aim of increasing the data protection and data security of our enterprise, and to ensure an optimal level of protection for the personal data we process. 8.	<p>INFORMATION COLLECTED BY REGISTRATION ON THE WEBSITE</p> <p>The data subject has the possibility to register on the website of the controller with the indication of personal data. Which personal data are transmitted to the controller is determined by the respective input mask used for the registration. The personal data entered by the data subject is collected and stored exclusively for internal use by the controller, and for his own purposes. The controller may request transfer to one or more processors (e.g. a parcel service) that also uses personal data for an internal purpose which is attributable to the controller.</p> <p>By registering on the website of the controller, the IP address—assigned by the Internet service provider (ISP) and used by the data subject—date, and time of the registration may also stored. The storage of this data takes place against the background that this is the only way to prevent the misuse of our services, and, if necessary, to make it possible to investigate committed offenses. Insofar, the storage of this data is necessary to secure the controller. This data is not passed on to third parties unless there is a statutory obligation to pass on the data, or if the transfer serves the aim of criminal prosecution.</p> <p>The registration of the data subject, with the voluntary indication of personal data, is intended to enable the controller to offer the data subject contents or services that may only be offered to registered users due to the nature of the matter in question. 9.	<p>INFORMATION COLLECTED BY SUBSCRIPTION TO OUR NEWSLETTERS</p> <p>On the website of the Connectico, users are given the opportunity to subscribe to newsletter service. The input mask used for this purpose determines what personal data are transmitted, as well as when the newsletter is ordered from the controller. The newsletter may only be received by the data subject if 1) the data subject has a valid e-mail address and 2) the data subject registers for the newsletter shipping. A confirmation e-mail will be sent to the e-mail address registered by a data subject for the first time for newsletter shipping, for legal reasons, in the double opt-in procedure. This confirmation e-mail is used to prove whether the owner of the e-mail address as the data subject is authorized to receive the newsletter. During the registration for the newsletter, a Website also store an IP address of the computer system assigned by the Internet service provider (ISP) and used by the data subject at the time of the registration, as well as the date and time of the registration. The personal data collected as part of a registration for the newsletter will only be used to send our newsletter.</p>
10.	<p>INFORMATION COLLECTED BY CONTACTING US VIA THE WEBSITE</p> <p>The website contains information that enables a quick electronic contact to Connectico. If a data subject contacts the controller by e-mail or via a contact form, the personal data transmitted by the data subject is automatically stored. Such personal data transmitted on a voluntary basis by a data subject to the data controller is stored for the purpose of processing or contacting the data subject. There is no transfer of this personal data to third parties.</p>

11.	<p>ERASURE AND BLOCK OF PERSONAL DATA</p> <p>The data controller process and store the personal data of the data subject only for the period necessary to achieve the purpose of storage. If the storage purpose is not applicable, or if a storage period expires, the personal data is routinely blocked or erased.</p>
